



ELEVATION

- Certified to meet CSA B45.5/IAPMO Z124 Standard.
- This unit can be reinforced to meet the accessibility requirements for Type B dwellings upon request.
- When installing this whirlpool, an access area should be provided near the location of the whirlpool pump for future access. An access area is required by many local, state & federal building codes.
- Recommended access area dimensions: W-20" [508mm] x H-15" [381mm]
- When properly accessorized and installed, product meets requirements of ADA (2010 Std), ICC/ANSI A117.1-2017, ABA or UFAS.
- Product has a Class B fire rating as determined by ASTM E-84 test method.
- Sufficient drain clearance to accommodate above the floor plumbing.
- Reinforced & slip resistant floor.
- Spacious bathing well with molded arm rests.
- Simulated tile walls with molded shelving.
- Integral 1" [25mm] nailing flange.
- Factory drilled 2 1/2" [64mm] overflow.
